Trainings Conducted by Extension Training Centre (ETC)

Training Programme on Planning & Management of IAY

The National Institute of Rural Development (NIRD) and Ministry of rural Development (MoRD) have entrusted the ETC to the responsibilities of conducting training programmes on Planning and Management of IAY. 3 programmes were conducted by ETC during the period July 2011-March 2012, a total of 107 participants were trained.



Training of Trainers (TOT-III) on Planning & Implementation of SGSY/NRLM

The ETC had conducted 8 numbers of TOTs on Planning and Implementation of Swarnjayanti Gram Swarozgar Yojana (SGSY) with special focus on Book Keeping. Book Keeping is one of the major components of SGSY. Book keeping in SHG Bank Linkage Programme requires that all primary books of accounts such as cash book, ledger, members' passbooks, individual members' ledger, receipt book and vouchers in the SHGs are maintained. The records should clearly state each member's savings, loans outstanding, interest and principal paid and such other relevant information. Furthermore, it is also essential that the accounts are kept up-to-date. A good book keeping maintenance is

a major challenge for SHGs and their members, especially when illiteracy is still a reality in many places.

Capacity Building under Backward Region Grant Fund (BRGF)

In Meghalaya, three (3) districts of West Garo Hills, South Garo Hills and Ri-Bhoi have been selected for the implementation of BRGF. As the State falls under the Sixth Schedule and is exempted from Panchayati Raj Act, the guidelines state that the mechanism developed for planning at village or cluster level, like the Village Employment Councils (VEC) and Area Employment Councils (AEC) set up under MGNREGA, be used for preparing participatory plans, implementation and monitoring of BRGF. The ETC, Nongsder had conducted 12 numbers of training programmes under BRGF for the year 2011-12. The programme was highly appreciated and participants expressed the necessity of such trainings for better implementation of RD programmes.



Capacity Building on Social Audit under MGNREGA

Although Social Audit is an embedded provision in the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), yet has been observed that the capacity of functionaries to implement the

statutory provisions of the Act is inadequate as a result of lack of training and capacity building. The ETC has taken up a number of programmes to develop the capacity of the functionaries to undertake social audit in relation to MGNREGS. The objectives of the programme are the following:

- ❖ To sensitize the participants at the field level on the importance and need for social Audit in MGNREGS
- ❖ To apprise the participants about the concept of social audit, its methodology and procedure.
- ❖ To help participants to consider the different components in planning and implementing of MGNREGS
- ❖ To acquaint the participants with the provisions of Right to Information Act, 2005 with regard to MGNREGA & Social Audit

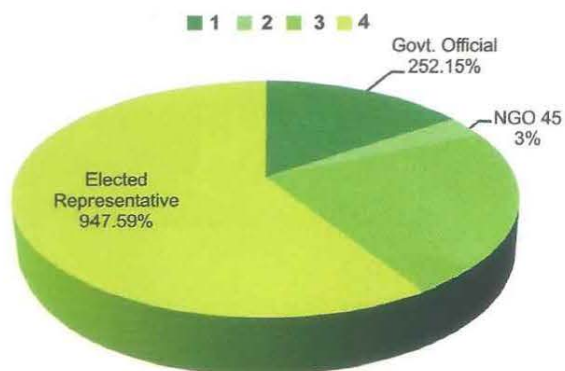


Block level training programmes with the above objectives were organized for the functionaries working at the field level in undertaking social audit under MGNREGA. 14 programmes were conducted, a total of 622 participants participated consisting of Chairman/Secretary/Member of VECs/PECs, Mates, Technical Assistants, Gram Sevaks/Sevikas and NGO. It has been observed that the participants were greatly benefitted by the programme.

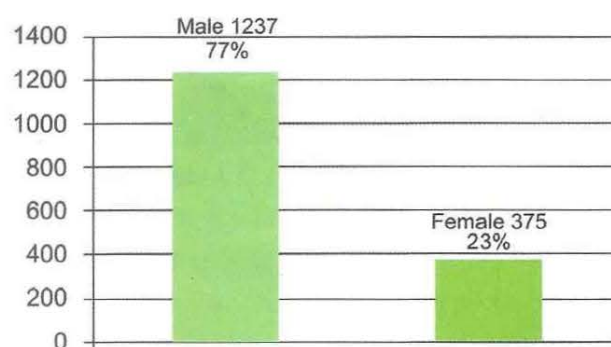
Training Performance (July -March, 2012)

During this period (July-March, 2012), a total of 46 training programmes were conducted including 7 in-campus and 39 off-campus programmes. A total of 1612 participants have been trained. The category-wise distribution of the participants includes- Government officials 252, Elected representatives 947, SHGs 368 and NGO 45.

FLAGSHIP PROGRAMME

Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)

MGNREGA is essentially a legislation to provide legally guaranteed employment of 100 days in a financial year to every registered rural household on demand.

National Rural Livelihood Mission (NRLM)

In 2009, the MoRD GoI started the process of restructuring the SGSY which culminated in the creation of NRLM. The basic purpose of NRLM is to put in place a dedicated and sensitive support structure for the poor from the national level to the village level. This mission will help the poor to build and sustain themselves through SHGs and Federations which will also provide them a platform for collective action based on self help and mutual cooperation such that they become a strong demand system, build linkages with mainstream institutions, including banks, and Government departments.

Rashtriya Swasthya Bima Yojana (RSBY)

RSBY is a health insurance scheme which provides cover for hospitalization expenses upto '30,000/- per annum for BPL family with nominal registration fee of '30/-.

Indira Gandhi National Old Age Pension Scheme (IGNOAPS)

IGNOAPS is a component of National Social Assistance Programme (NSAP) that provides old age pension to the tune of '200 per beneficiary per month belonging to a BPL family whose age is 65 years and above.

Indira Gandhi National Disabled Pension Scheme (IGNDPS)

One of the components of NSAP is the IGNDPS that provides monetary benefit of '200 per month to beneficiaries who are physically challenged falling within the age group of 18 to 64 years and belonging to BPL families.

Indira Gandhi National Widows Pension Scheme (IGNWPS)

IGNWPS, a component of NSAP provides monetary assistance to widows of BPL families in the age group of 40 to 64 years at the rate of '200 per month.

National Family Benefit Scheme (NFBS)

The NFBS is a scheme that provides one time assistance of '10,000/- to BPL families who have lost the primary bread winner.

Indira Awaas Yojana (IAY)

The Indira Awaas Yojana, provides '48,500/- for construction of dwelling units for BPL families.

Pradhan Mantri Gram Sadak Yojana (PMGSY)

The Primary objective of PMGSY is to provide connectivity by way of all weather road necessary culverts and cross drainage structures, which is operable throughout the year to the unconnected habitation in the rural areas.

Integrated Watershed Management Programme (IWMP)

The Basic objective of this scheme is integrated wastelands development based on village or micro watershed plans. The Government of India is taking up this task by revitalizing and reviving village level institutions and enlisting people's participation in the development of clusters of micro watersheds in a holistic manner rather than piecemeal treatment in sporadic patches.

Backward Regions Grant Fund

A programme aimed at redressing regional imbalances by providing financial resources for supplementing and converging developmental inflows by

- Bridging critical gaps in local infrastructure and requirements not met through existing inflows
- Strengthening Village Institutions and Municipal Governance to facilitate
 - Participatory planning and decision making to reflect local needs
 - Implementation and monitoring
 - Providing professional support to local bodies
 - Improving performance and delivery of critical functions assigned to village institutions and create efficiency and local capacity to counter equity losses

Total Sanitation Campaign

- A new approach for ensuring hygiene and sanitation in the villages

- ❑ Through Community Led Total Sanitation (CLTS) – Volunteers of TSC will approach the villages guiding them to achieve total sanitation
- ❑ Villagers to help them in holding meetings for the purpose and help them in all logistical help if they require

- ❑ Idea is to stop open defecation and use SAFE Toilets so that the spread of diseases in the village can be minimized and surroundings of the village are clean and hygienic.
- ❑ Villagers to form a committee called Village Water and Sanitation Committee (VWSC) about which volunteers will tell the villagers in detail.

Ha u snem 2009, ka MoRD, Gol ka la shim ia ka sien jam ban pynthymmai noh ia ka rukom treikam jong ka SGSY ha kaba la mih syndon da ka NRLM. Ka jingthmu ba kongsan jong ka NRLM ka long ban buh ia ka rukom treikam kaba khlain naduh ka kyrdan ba ha khlieh duh jong ka ri shaduh ki shnong ki thaw na ka bynta ban peit ban khmih ia kiba duk ba kyrduh, ban thaw bad ban pynneh ia ki SHG bad ki Federation ha la ki kyrdan treikam jong ki. Ka IGNOAPS ka dei ka bynta jong ka National Social Assistance Programme (NSAP) ka ba pynioh ia ka bai bam tymmen ha ka dor '200/- tyngka shi bnai na ka bynta kito kiba hap hapoh ki longing BPL bad ba ka karta jong ki ka la kot ia ka 60 snem shaneng.

Indira Gandhi National Disabled Pension Scheme (IGNDPS)

Kawei pat ka bynta jong ka NSAP ka dei ka IGNDPS ka ba pynioh ia ki lad jingiarap ha ka dor kaba '200/- tyngka shi bnai na ka bynta kito kiba don ki jingduna ha ki dkhot met kiba hapdeng ka karta kaba 18 haduh 60 snem bad ba dei na ki longing BPL.

Indira Gandhi National Widows Pension Scheme (IGNWPS)

Ka IGNWPS, ka bynta jong ka NSAP kaba kyrshan ia ki thei iap tnga kiba wan na ki longing BPL kiba ka karta jong ki ka long hapdeng 40 haduh 60 snem ha ka dor kaba '200/- tyngka shi bnai.

National Family Benefit Scheme (NFBS)

Ka NFBS ka dei ka skim kaba ai jingiarap tang shisien ai ha ka dor '10,000/- tyngka na ka bynta ki longing BPL kiba la duh noh ia u nongpyndap pynbiang ba kongsan jong ka ing.

Indira Awaas Yojana (IAY)

Ka Indira Awaas Yojana, ka pynioh '48,500/- tyngka ban shna ia ki ingsah na ka bynta ki longing BPL.

Pradhan Mantri Gram Sadak Yojana (PMGSY)
